#### Summaries of Legislation Passed in January—March 2017

#### Supplementary Appropriation Act 2017 (Act)

The Act authorizes the issue and appropriation of certain sums of money out of the Treasury Fund to Ministerial/Departmental Outputs and Sub-outputs, Outputs provided by Third Parties and Transactions on Behalf of the State for the Financial Year ending on the 30th day of June 2017.

#### Coroners Act 2017 (Act)

The Act repeals the Coroners Ordinance 1959 and provides a

coronial system to investigate sudden or unexplained deaths or deaths in special circumstances through inquiries and inquests to help prevent deaths in circumstances similar to those deaths and for related purposes.

#### Police Service Amendment Act 2017 (Act)

The Act seeks to amend the Police Service Act 2017 to allow the Head of State, on the advice of the Cabinet, to suspend or terminate the Commissioner or Assistant Commissioner under certain circumstances without the need to establish a Commission of Inquiry if it is clear and substantial there are grounds for suspension or removal. The Act inserts same provisions into the Prisons and Corrections Act 2013 and the National Prosecution Office Act 2015 for uniformity. These new changes are an exception to the general rule which is a Commission of Inquiry or Tribunal may still be held if there is a need to do so.

#### **Tax Information Exchange Amendment Act 2017** (Act)

The Act seeks to amend the Tax Information Exchange Act 2012 with the objective to implement the obligations of Samoa under an agreement for the implementation of the Standard on



Automatic Exchange of Financial Account Information in Tax matters.

#### Village Fono Amendment Act 2017 (Act)

The Act seeks to amend the Village Fono Act 1990 to strengthen our culture to ensure stability in Samoa by strengthening the role of the Village Fono and to ensure that the exercise of the powers of the Village Fono are in accordance with the Constitution.



The Act covers the following:

- the granting of a specific power to impose curfews and banishment;
- the inclusion of limited jurisdiction over those living in government, lease or freehold land located within village lands;
- the provision of specific power to Village Fono to make their own faiga faavae or iugafono and register them at the Ministry of Women, Community and Social Development in order for them to be recognized by the Court. However, the registration of faiga faavae or iugafono do not necessarily mean that they are consistent with the Constitution;
- the requirement to consult and obtain the approval of the Village Fono before any building or activity can be undertaken. If the Alii and Faipule decline the proposed activity or building, the decision can be appealed to the Land and Titles Court.

#### Police Powers Amendment Act 2017 (Act)

The Act seeks to amend section 13 of the Police Powers Act 2007. It authorises the Minister responsible for the Samoa Police Service to approve a police officer to be armed under exceptional circumstances, in accordance with relevant police internal orders or prescribed rules and after consultations with the Attorney General.

#### JUDICIAL CHURCH SERVICE


The Judiciary of Samoa started off the year 2017 with their annual church service on 13 January 2017 that was attended by members of the Ministry of Justice and Courts Administration, government officials and members of the Samoa Law Society. The service was conducted by Afioga Patele Paulo Filoialii to bless the work of the Judiciary service for the year. His Honour Chief Justice Patu Falefatu Maka Sapolu in delivering the keynotes of the service acknowledged the hand of God over the past years.



#### INTERNATIONAL ESTATE PLANNING COURSE

The Samoa International Finance Authority hosted a 2 weeks Course from 6th-17th February on International Estate Planning ("IEP") at their Conference room basically to further knowledge and understanding of the attendees on the different types of IEP available in Samoa. Comparisons and contrasting were made between the types of IEP such as Trusts, Companies, Special Purpose International Companies and especially Foundations which is a new entity that has just been recently introduced in Samoa under the Foundations Act 2016.

The presentation by Mark Lea who conducted the Course covered all details of each IEP's, their aspects, implications, impacts and their natures.



The Course will be commenced again next year in August 2018.

State Solicitor Terina Sefo and Law Clerk Jacek Tuala attended the Course on behalf of the Office of the Attorney General.



### EU-GIZ Adapting to Climate Change and Sustainable Energy (ACSE) Programme Technical Group Meeting for the Energy Bill & Sustainable Bioenergy in Samoa Project

The Ministry of Finance under the EU-GIZ ACSE Programme for the Energy Bill and Sustainable Bioenergy in Samoa Project invited representatives from various Government Ministries and Agencies who are assisting in supervising and monitoring the implementation of the projects to a Technical Working Group on Thursday, 2nd February 2017.

The purpose of the meeting was for the Technical Working Group to discuss any challenges key implementing agencies are facing and review the existing Working Plan. Input from all key implementing agencies is vital to ensure that the Project activities remain on track and to address any issues

hindering completion of Project activities within the allocated timeframes.

Senior Legislative Drafter Mearold S. Viliamu attended on behalf of the Office of the Attorney General.



#### TALK BY HAMPTON QC

The Office of the National Prosecutions Office made use of Hampton's QC time here in Samoa who was involved in some of the Government Court proceedings and invited him to give a talk about basic skills

give a talk about basic skills and knowledge of what every prosecutor should acquire. Members of the Attorney General's Office were also invited to sit in the session. The Attorney General himself, Mr. Lemalu Hermann P. Retzlaff was also present and talked side by side with Hampton QC on the purpose of the session. It was a good chance especially for young lawyers who attended the session to learn from a person with expertise in prosecutions. The Attorney General thanked Hampton QC after the

session and wished him well.

#### PERSONAL PROPERTY SECURITY REGISTER SYSTEM SESSION

The Ministry of Commerce, Industry and Labour (MCIL) organised a special session in relation to the Personal Property Securities Act 2013 (PPSA) that commenced on 27 February 2017 and also the new online personal property security register system. One of the main

objective of the new system is to improve access to finance and to increase economic activities by way of online registration. The session was conducted by three lawyers from New Zealand who are experts in this particular area of law.

Demonstrations were made as to how to register online on the MCIL Online Samoa Company Registry, and was followed by questions and discussions as to how the system will work. Representatives who attended the session were mostly private lawyers, and Tacy Sasagi and Jacek Tuala of the LDD team attended on behalf of the Office of the Attorney General.



#### CUSTOMARY LAND ADVISORY COMMITTEE STAKEHOLDER CONSULTATION ("CLAC Consultation") 21 February 2017 MNRE Conference Room

The CLAC Consultation aimed to discuss two aspects of the project, first is the update from public consultations the CLAC carried out throughout the country in relation to the mortgage of customary leases, and second is the development of the CLAC strategic plan for the next three years.

As follow were the major issues discussed during the Consultation:

- Payment of lease funds to beneficial owners;
- Minister signing customary land lease agreements on behalf of beneficial owners; and
- Terms of leases including right to renewal.

The public raised concerns about the payment of lease funds and they are urging the Taskforce to look at ways to equally distribute lease funds amongst beneficial owners. The Samoa Law Reform Commission responded that they are currently working on the Pule a le matai Sa'o issue and most of these issues will be addressed (hopefully) when the report is finalised.

Moreover, the beneficial owners indicated that one of them should sign the lease together with the Minister. The taskforce indicated they will take this into account but having the Minister to sign these leases is to safeguard the beneficial owners from legal actions against them.

The public also raised that the terms of leases of customary land and right of renewal might end up in the alienation of customary land. Pursuant to Alienation of Customary Land Act 1965, for hotels and industrial purposes, the lease of customary land can be made up to 30 years and 20 years for all other public purposes. The taskforce assured the public that Article 102 of the Constitution of Samoa prohibits the alienation of customary land.

Representatives from all relevant stakeholders including heads of several Government Ministries and Corporations, they voiced some of the issues faced by their respective Ministries in relation to customary land matters. Senior Legislative Drafter Jasmine Faleafaga and Law Clerk Ann Matalasi from the Legislative Drafting Division attended the CLAC Consultation on behalf of the Office of the Attorney General.

#### LDD BEGINNERS TRAINING

Chief Legislative Drafter Noumea L. Teueli conducted a 2 hours training on 14 February 2017 at the AGO Conference room to the advantage of new drafters of the LDD team. The main objective of the training was to teach new drafters on basic aspects and requirements of legal drafting. The following were some of the issues discussed:

- ♦ Legislation: Primary, Subsidiary and By-laws
- ♦ Purpose of Consultation
- Acts to be considered when drafting any legislation.

It was also a good opportunity for senior drafters to refresh knowledge.

#### LDD MONTHLY TRAINING

The LDD team has been conducting internal trainings particularly in relation to each Drafters' legislation or any legislative instrument they are currently working on. Trainings are conducted monthly, and 2 Drafters have to present and discuss with the team and the Office the purpose of the matter they are working on, the status of the matter, and also issues that may be raised during the presentation. #### PACIFIC DISABILITY FORUM

The 5th Pacific Disability Forum was held on 20th-24th February 2017 at the Hotel Tanoa Tusitala Hotel Conference Room in Apia, Samoa, whereby Titilua Aiono, State Solicitor and Tacy Sasagi, Part-time Law-Clerk attended on behalf of the Of-

fice of the Attorney General for the last two days of the workshop.

The discussions and activities were based according to the theme: "Build a more inclusive and equitable pacific for all persons with disabilities". The Pacific Disabilities Forum (PDF) has convened four regional conferences and have contributed and assisted in shaping and progressing their work at the national, regional and international level.

There was a division of small meetings amongst different forums that focuses on a specific group with disabilities that was discuss each day of the conference that mainly focuses on targeted objectives of each meetings and the expected outcomes. These involved:

- (i) The youth forum, the main objective for the forum was to provide opportunities and space for young persons with disabilities from Pacific Island Countries and territories to discuss how they can contribute to and benefit from the building of an inclusive and equitable Pacific; and
- (ii) The women forum to bring together women leaders with disabilities to share thoughts, insights and experiences on priority areas of focus to build an inclusive and equitable Pacific for women and girls with disabilities.

The meeting output prepared a final report from all the discussions from the Forums that concentrate mainly on the key discussions and recommendations presented by this forum and to provide an action plan to guide PDF's work programmes to be shared with members, partners and interested stakeholders on improving priority areas for disability
